

Investment Focused Networking Sessions to Debut at the NIC 2015 Forum

Annapolis, Maryland, February 9, 2015 -- A new facilitated networking opportunity *Capital Connections*, will premiere at the upcoming **NIC 2015 Capital & Business Strategies Forum** in San Diego, March 31-April 2. This is a networking opportunity specifically designed to foster meaningful connections for financing and investing opportunities between Capital Providers and Capital Seekers - with particular emphasis on capital requirements for small and mid-cap operators in seniors housing and postacute care.

The networking sessions will feature 39 capital providers presenting "pitching" their financial solutions to capital seekers.
